Ed, W0EJL sent me some of his recollections of the beginnings of the Nebraska Storm Net. It's good to know the Storm Net has some great beginnings and I am sure some of you may have additional rememberences, feel free to send them to me. Here are Ed's notes as he sent to me for your interest:

I recall some history of the Storm Net.

Sometime in the 1960s, (March 1966 I think) the north central part of the state received a nasty snow storm. Our phone lines were all aerial at the time and service became almost non existent. The local phone company was experimenting with something called wide span lines. Poles were spaced so far apart, on hot days the wires laid on the

ground. When the lines iced up or we received high winds, the lines came down, either turning poles in the ground or breaking them off, sometimes a half mile at a time.

Orders were delivered by amateur radio for snow plow fuel, a drug store in Atkinson received drugs from Omaha as the result of amateur relayed orders. Many other welfare situations were handled by amateur traffic.

A member of the Central Nebraska Amateur Radio Club came up with the idea for a local net to cover these disasters. Larry Abbott, KØJXN, a quadriplegic operator living on a ranch west of Taylor came up with a plan for a net and he dubbed it the Storm Net. The club members hung out on 3.960 at the time, so that's where we met every evening. KØPZS, Wayne at Broken Bow and WØFIG, Ed at Burwell (later WØEJL) were the first NCS operators for some time. We soon burned out and several other members stepped in to pick up other evenings. It soon became a state wide affair and other NCS operators became involved. I don't know when the net moved to 3.982. el.

Ed, W0EJL sent me some of his recollections of the beginnings of the Nebraska Storm Net. It's good to know the Storm Net has some great beginnings and I am sure some of you may have additional rememberences, feel free to send them to me. Here are Ed's notes as he sent to me for your interest:

I recall some history of the Storm Net.

Sometime in the 1960s, (March 1966 I think) the north central part of the state received a nasty snow storm. Our phone lines were all aerial at the time and service became almost non existent. The local phone company was experimenting with something called wide span lines. Poles were spaced so far apart, on hot days the wires laid on the ground. When the lines iced up or we received high winds, the

lines came down, either turning poles in the ground or breaking them off, sometimes a half mile at a time.

Orders were delivered by amateur radio for snow plow fuel, a drug store in Atkinson received drugs from Omaha as the result of amateur relayed orders. Many other welfare situations were handled by amateur traffic.

A member of the Central Nebraska Amateur Radio Club came up with the idea for a local net to cover these disasters. Larry Abbott, KØJXN, a quadriplegic operator living on a ranch west of Taylor came up with a plan for a net and he dubbed it the Storm Net. Ed, W0EJL sent me some of his recollections of the beginnings of the Nebraska Noon Net. Here are Ed's notes as he sent to me for your interest:

"As early as I recall, the noon net took nominations for a net manager once a year.. The net manager selected a couple alternates, but was expected to be the NCS daily..

On one day, the members could vote for a nominee on the air, or mail their selection to the NCS who announced the winner, (who may consider themselves

losers, in some instances)... I was that loser in about 1963.. I said if elected, I'd call the net with SSB, it had always been AM before.. It worked out well, no griping that I recall.. WØEGQ, Bob McMullen was net mgr before I came in and WØYFR Erv Johnson from Sutton and someone who I don't recall, (May have been KØJFN Tom from Fremont) tied with the vote.. I advised the net of the result and told them they could select a winner or have two managers, whatever.. The net was called the (Nebraska Emergency Phone Net) at that time... Some time later it became the (Cornhusker NET), but I don't recall when or why it was changed..

Maybe someone else has more answers on that for you.. el.."

Ed, W0EJL penned some notes about the beginnings of the Nebraska Storm Net.

NEBRASKA NETS: For want of something to fill some space, I've decided to feature some history of the Nebraska nets starting with the STORM NET..

The Nebraska sandhill area had a rather severe snow storm in the late 1960s.. The phone company had been experimenting with a cost saving system called wide span.. They were using 1 pole where 3 had been before.. On this 1960s storm, ice collected on the lines and if broadside winds didn't break the poles, up to 1/2 mile sections of poles were turned over in the ground and then it snowed.. The CNARC Club was active at the time and usually hung out on 3.960.. We handled orders for a drug store in Atkinson, directed tank trucks with gas to snow plows and several other storm related situations..

When the "dust" settled, Larry KØJXN, a handicapped operator on a ranch in

Loup county drew up a plan to start a network that became the NE Storm Net and I'm not sure when, but finally it gravitated to 3.982 where we still meet..

Wayne, KØPZS near Broken Bow and WØFIG, Ed near Burwell were selected as the first NCS operators..

We had mobile operators at the Wolbach, Primrose tornados and handled traffic for individuals, law officers even the National Guard.. I remember at Primrose, a state trooper drove up with a 5 gallon can of gas for our generator.. We left the next day when the phone company got a couple out going lines hooked up.. We were at the Halsey Forest fire sending reports to the EOC in Lincoln and assisted with H & W messages after the Grand Island tornados in 1980..

For some reason Wayne and I quickly tired of the NCS duties and through the years, several people acted as net control operators..

Somewhere along the way, a net manager system appeared and different NCO stations are assigned different days which works very well..

I'm expecting some data on the Western Nebraska Nets soon.. If anyone has memories of the other Nebraska nets' past histories, send them to me and we'll fit it in during the next few months..
